The European University of Brcko District and the European University "Kallos" Tuzla are organizing the tenth International Scientific Conference on May 13, 2022 on the topic

FOOD SAFETY AND QUALITY

Recently, we have witnessed an increasing withdrawal of food supplements and supplements from supermarket shelves in the European Union, as well as in Bosnia and Herzegovina and other countries, due to the presence of the carcinogenic pesticide ethylene oxide or other illicit substances. Other food contaminants, in addition to pesticides, include various veterinary drugs, microtoxins, various metals and non-metals, biotoxins, histamines, and many others. The European institutions even discovered that horse meat was sold as veal, and some withdrawn products had a label of organic origin, i.e. a declaration that they come from organic farming.. Consumers are often served information that the product is of domestic origin, while on the back of the product it is written that the raw materials are in fact imported from abroad. However, this information is frequently written in such small letters that it is difficult to read.

According to statistics from the World Health Organization (WHO), about 3 million poisoning annually are caused by pesticides, of which as many as about 220,000 with a fatal outcome. States regulate by law the permissible level of pesticide presence in food, which is not considered harmful to the human body. However, science has proven that even low amounts of pesticides in foods that are consumed in the long run can have harmful effects on the body. The most common diseases associated with the body's exposure to pesticides are severe consequences for the nervous system, poor memory, reduced motor skills, various allergies, hormonal problems, as well as

diseases of the reproductive system. Even the presence of pesticides in the body is associated with the appearance of cancer cells.

The human factor destroys and pollutes both water and soil, on which the cultivation of healthy food depends, and the existence of the human race again depends on food. It is pointless to talk about anything else if the survival of the human race is endangered, and it is endangered. The theme of this scientific conference is *Food Safety and Quality*, and the task of the participants is to answer a number of important questions that are asked in connection with this topic, such as:

How can the state contribute to protecting consumers from consuming products that contain harmful substances?

How to preserve natural resources such as water and agricultural land from contamination?

How to move from mass to organic farming and food processing?

Is there anything else that can be done internationally to combat the causes of water and soil pollution?

What is the normative regulation in the European Union when it comes to the presence of illicit substances in food and other issues related to this topic?

What diseases are caused by food insecurity and what are the treatment options?

And a number of other issues that are relevant to this topic.

Volume of the work - up to 15 A4 pages

Paper title - uppercase letters (Times New Roman 14 Bold) Subheadings -

lowercase letters (Times New Roman 12 Bold)

Text - with spacing (Times New Roman 12), in one of the official languages in use in Bosnia and Herzegovina, or in one of the world's foreign languages.

Footnotes - Times New Roman 10

Mandatory abstract / summary with key words, which should also be translated into English.

If the article was written by several authors, and they are engaged in different institutions, it is necessary to indicate in the footnote which of the listed institutions represents each of the listed authors (it is possible to list several institutions). It is possible to have a maximum of three co-authors of one article, and each (co) author can participate with only one written work.

Bibliography - cited literature includes bibliographic sources, such as articles, monographs, etc., and is given exclusively in a separate section of the article in the form of a list of references.
