**Dear colleagues,**

The European University of Brcko District and the European University "Kallos" Tuzla organize on the 13th of April 2018 the Sixth International Scientific Meeting devoted to

### **CURRENT PROBLEMS OF HIGHER EDUCATION AND SCIENCE**

and invites you to take part in the scientific meeting. Although higher education and science are permanently reformed, it remains to be noted that what has been done is not adequate to the society in which we live and act. In other words, the discrepancy between the reality of the European Union, Europe, and the reality of the post-Slavic states in the field of education is growing, not only in the field of natural and technical sciences, but also in the sphere of social, which causes disaster. The incompatibility of the system of values, moral norms, ambitions and expectations of young people, the lack of motives for studying (learning) of young people and the reality of the labor market indicate that it is necessary to re-examine everything related to higher education and point out possible ways of overcoming the problems that have arisen. Globalization of education also leads to the issue of culture and cultural identity, and all of this has not been sufficiently studied, especially from the aspect of the consequences. Also, a number of practical problems have not been harmonized with the neighboring countries, from where students come to study in Bosnia and Herzegovina, and this is an opportunity to start a scientific, not just legal dialogue.

Science is also being reformed, but the belief is that this is done in a way that promotes globalization, which often acts as an organized plunder of small states, in particular by insisting that scientific papers be published in certain western journals. Also, the evaluation of scientific work is increasingly archaic, and the conference could also contribute to the resolution of science-related issues. Namely, the statistics of the published scientific papers show that Bosnia and Herzegovina lags behind similar countries by the number of inhabitants and the area of the territory, which is reflected in the ratings of universities. It should be noted that without the scientific work of university professors there is no improvement in the rating of universities, and that this issue has an internal significance.

In any case, there are many questions, and we expect everyone, within their own interests, to determine the topic of the research, and in that way try to contribute, if not solving, then to better understand the current issues related to the topic of the scientific meeting.

We invite you to participate in the *Sixth International Scientific Meeting* with your scientific or professional work.

## TECHNICAL INSTRUCTIONS FOR AUTHORS

Scope of the abstract up to 15 pages.

The title should be written in capital letters (Times New Roman 14 Bold) while the subtitles should be written in small print. (Times New Roman 12 Bold). The text should be written with spacing 1 (Times New Roman 12).

Mandatory abstract/summary with key words, which should be translated into English.

If the article is written by several authors, and have been engaged in various institutions, it is necessary in a footnote to indicate which of these institutions represents each of these authors. (Can specify multiple institutions).

It is possible to be a maximum of three authors of an article.

Bibliography–quoted literature encompasses bibliographic sources such as articles, monographs and the like, and is given exclusively in a separate section of the article in a list of references.

The registration fee per participant is 100,00 KM (50 Euro). Registration fee includes: participation in the conference, proceedings, a certificate and a gala dinner. The registration fee is to be paid until the 7<sup>th</sup> of April 2018 to the current account of the *Evropski univerzitet Brčko*: 555 003 005 11 429 27.
