## **C O N T R A C T**

### **ON ACADEMIC, SCIENTIFIC AND BUSINESS TECHNICAL COOPERATION**

#### **Article 1**

The contract is concluded with the aim of cooperation between two higher education institutions in the future process of education, pedagogy, scientific research and other activities within the registered activity.

#### **Article 2**

The Contracting Parties shall endeavor to develop mutual academic links according to the principles of common benefit, general social interest, and common complementary activities of higher education. The contracting parties will make the greatest and sincere efforts to implement this contract at the academic level

#### **Article 3**

Objectives of cooperation:

- development and encouragement of joint research, seminars, international conferences, with the efforts to provide external sources of funding;
- developing the exchange of knowledge and scientific information through the reciprocal exchange of scientific and professional publications, e-publications, academic materials, professional resources and other resources;
- encouraging other academic projects and activities directed towards other academic partners and other sources of financing non-profit and academic projects;
- encouraging other academic activities for which both parties agree that they are of common interest and use.

#### **Article 4**

The field of cooperation will include any academic and other scientific relations, professional programs that are accredited and registered in any of the institutions in

order to develop joint activities in teaching and academic fields that are of mutual interest, based on quality and reciprocity.  
The Contracting Parties shall submit proposals relating to joint projects under the terms of this Contract through a managerial executive staff or through competent academic staff.

**Article 5**

The Contracting Parties may agree to display on their website the logo of the other Contracting Party, at the appropriate place, with a link to the website of the other Contracting Party.

**Article 6**

The Contracting Parties shall resolve any disputes by mutual consent.

**Article 7**

This contract is made in four (4) copies, each Contracting Party shall receive two (2).

**Article 8**

The Agreement shall enter into force on the date of signature of both Contracting Parties.
