- Aplikant treba popuniti online prijavu i poslati jednogminutni video u kojem objašnjava zašto smatra da je najbolji kandidati za Program;
- Aplikant treba dostaviti izjavu kojom dokazuje zainteresiranost za područja koja se odnose na održivost (podnosilac prijave treba imati istinski interes za oblasti kao što su: održivost, životna sredina, tehnologija, energija i vještine).

Offering participants hands-on experimental learning, self-paced studying of comprehensive content and networking opportunities; FSL equips them with key skills to succeed in the green jobs of the future in an ever more digitally advanced and complex world.

Selected nominees will have the opportunity to participate in Abu Dhabi Sustainability Week (ADSW) 2024, the region's largest sustainability gathering. - Hold an undergraduate degree, or be pursuing one, at an accredited institution (open to all majors)
- Have excellent spoken English
- Submit a statement demonstrating interest in sustainability-related fields
- Complete the online application form before **Tuesday, October 31, 2023**.

**Future Sustainability Leaders - Roles and Responsibilities:**

- Complete the Skillup Series online learning units
- Attend all Virtual Series and events throughout the year (such as Abu Dhabi Sustainability Week etc.)
- Participate in the Y4S Innovation Lab (through the Ecothon Innovation Challenge)
- Promote FSL program through your social network (when applicable)
- Coordinate, manage tasks and work under pressure
- Have a positive attitude and be a 'people person'
